

  - 4. The Reporting Trustee Shri. Bramanand Bajiraoji Karanjekar (A.W. No.1) filed her Affidavit of Examination-inchief at Exh.10. The notice of General Body Meeting was issued on 08.05.2022 for holding the General Body Meeting on 11.05.2022. In that General Body Meeting dated 11.05.2022 the new Executive Committee is elected for the





tenure of five years. Thereafter, the present change report is filed for recording the change occurred into the trust.
